

## **Notice of Accreditation Actions**

Fall 2013 - Amended 12/23/13

Accrediting agencies recognized by the Council for Higher Education Accreditation are required to notify the public of the basis for final accreditation decisions. The Joint Review Committee on Educational Programs in Nuclear Medicine Technology (JRCNMT) meets this requirement by publishing a notice of accreditation actions on its website after each board meeting. The nuclear medicine technology community, regional and specialized accrediting agencies, and state agencies responsible for postsecondary education and radiation oversight are notified when a new notice of action is published.

At its meeting on November 8 - 9, 2013 the JRCNMT took the following actions regarding the nuclear medicine technology programs sponsored by the institutions listed below. **Probationary Accreditation** - The term for probationary accreditation is typically up to one year, though in rare instances it may be for up to two years. A satisfactory progress report and focused site visit are required for conversion of probationary accreditation to continued accreditation.

**Thomas Jefferson University (PA)**

Probationary accreditation extended to April 2014

Progress report requested on standards B2.1a (2 areas), B4.1, C2.4g, and E2.2

**Voluntary Withdrawal of Accreditation** - This action is taken at the request of an accredited program.

Voluntary withdrawal of accreditation due to program closure, effective August 31, 2014

**Kent State University Salem Campus (OH)**

Voluntary withdrawal of accreditation due to program closure, effective December 31, 2014

**Cedar Crest College (PA)**

Voluntary withdrawal of accreditation due to program closure, effective August 1, 2013

**Active/Inactive Program Status** - Inactive status is granted when a program has no students currently enrolled. Inactive status is limited to a two-year period. Reactivation is granted when a program submits a report indicating the program continues to be in substantial compliance with accreditation standards and enrolls students.

**Prince George's Community College (MD)**

Approved: reduction in program length; addition and deletion of prerequisites; re-sequencing of professional curriculum

**Pennsylvania College of Health Sciences (PA)**

Approved: add Cedar Crest College as an academic affiliate and absorb that program's clinical affiliates

**Southeast Technical Institute (SD)**

Approved: reduction in semester length and reduction in didactic content hours

**Houston Community College (TX)**

Approved: initial plan to extend program to Dallas, TX with the addition of a clinical coordinator and major clinical affiliates
