# **Notice of Accreditation Actions**

Spring 2014

Accrediting agencies recognized by the Council for Higher Education Accreditation are required to notify the public of the basis for final accreditation decisions. The Joint Review Committee on Educational Programs in Nuclear Medicine Technology (JRCNMT) meets this requirement by publishing a notice of accreditation actions on its website after each board meeting. The nuclear medicine technology community, regional and specialized accrediting agencies, and state agencies responsible for postsecondary education and radiation oversight are notified when a new notice of action is published.

At its meeting on April 4 - 5, 2014 the JRCNMT took the following actions regarding the nuclear medicine technology programs sponsored by the institutions listed below. Specific standards listed in this report can be reviewed in the JRCNMT Accreditation Standards for Nuclear Medicine Technologist Education.

**Continued Accreditation** - Programs in this category have completed a self-study and on-site evaluation. The term for continued accreditation is up to seven years.

# **Community College of Allegheny County (PA)**

Continued accreditation conferred to December 31, 2016 Progress report on standards B1.1, B4.2b and C2.1a due August 1, 2014

## South College (TN)

Continued accreditation conferred to December 31, 2019 Mid-cycle report due February 2016

**Accreditation Extended**- Programs in this category have submitted an interim report demonstrating compliance has been achieved on previously cited standards, allowing extension of the previous accreditation award up to a maximum of seven years.

Extension of accreditation four years through December 31, 2020 Mid-cycle report due February 2017

Extension of accreditation one year through December 31, 2020 Mid-cycle report due February 2017

### **Cuyahoga Community College (OH)**

Extension of accreditation two years through December 31, 2016 Progress report due February 2016

### Thomas Jefferson University (PA)

Probation removed; extension of accreditation two years through December 31, 2016 Progress report due February 2016

## **Galveston College (TX)**

Extension of accreditation two years through December 31, 2020 Mid-cycle report due February 2017

### **Bellevue College (WA)**

Extension of accreditation five years through December 31, 2020 Mid-cycle report due February 2017

**Initial Accreditation Extended**- Programs in this category received initial accreditation three years prior; after submission of an interim report demonstrating continued compliance with the Standards accreditation may be extended for up to two years.

# Allen College (IA)

Two-year extension of accreditation to December 31, 2016 Self-study and site visit for continued accreditation due in 2016

## Frederick Community College (MD)

Two-year extension of accreditation to December 31, 2016 Self-study and site visit for continued accreditation due in 2016

**Voluntary Withdrawal of Accreditation** - This action is taken at the request of an accredited program.

## **Jackson Memorial Hospital (FL)**

Voluntary withdrawal of accreditation due to program closure, effective February 19, 2014

Active/Inactive Program Status - Inactive status is granted when a program has no students currently enrolled. Inactive status is limited to a two-year period. Reactivation is granted when a program submits a report indicating the program continues to be in substantial compliance with accreditation standards and enrolls students.

### West Virginia University Healthcare (WV)

Approved reactivation, effective April 4, 2014

## **Substantive Change Requests**

### Molloy College (NY)

Approved: conversion of program from AAS degree to BS degree; effective fall semester 2014.

### **Caldwell Community College and Technical Institute (NC)**

Approved: addition of diploma track for graduates of accredited radiography programs.

### **Houston Community College (TX)**

Approved: addition of program satellite in Dallas, TX.
