

Notice of Accreditation Actions

Fall 2019 – Revised January 10, 2020

Accrediting agencies recognized by the Council for Higher Education Accreditation are required to notify the public of accreditation decisions and the basis for such decisions. The Joint Review Committee on Educational Programs in Nuclear Medicine Technology (JRCNMT) meets this requirement by publishing a notice of accreditation actions on its website within 30 business days after each board meeting. Beginning in June 2019, the JRCNMT will post program accreditation letters in the online directory of accredited programs. The nuclear medicine technology community, regional and specialized accrediting agencies, and state agencies responsible for postsecondary education and radiation oversight are notified when a new notice of action is published.

At its meeting on October 25 - 26, 2019 the JRCNMT took the following actions regarding the nuclear medicine technology programs sponsored by the institutions listed below. Accreditation Extended- *Programs in this category have submitted an interim report demonstrating compliance has been achieved on previously cited standards, allowing extension of the previous accreditation award up to a maximum of seven years.*

Loma Linda University (CA)

Accreditation is extended two years. Accreditation is conferred through December 31, 2021.

Miami Dade College (FL)

Accreditation is extended two years. Accreditation is conferred through December 31, 2022.

Accreditation Continued - *Programs in this category have completed a self-study and on-site evaluation and was found to be in compliance with all JRCNMT standards. The term for continued accreditation runs through December 31, 2026 (seven years). A Mid-Cycle report is due in 2023.*

South College (TN)

Accreditation with Conditions – *Programs in this category have completed a self-study and on-site evaluation but were found to have deficiencies in meeting the noted standard(s). A progress report documenting attainment of compliance with each standard is required for accreditation to be continued.*

The Johns Hopkins Hospital (MD)

A progress report on standards B1, B2.1a, D2.2, E1.1 and E1.2 is due February 3, 2020.

University of Cincinnati (OH)

A progress report on standards B5, D3.3 and E3.3 is due February 3, 2020.

Ohio State University Wexner Medical Center (OH)

A progress report on standards A2.2g, A2.3 and D3.1j is due February 3, 2020.

Rhode Island Hospital (RI)

A progress report on standard C1.1 is due February 3, 2020.

Old Dominion University (VA)

A progress report on standards B2.3a and D3.2 is due February 3, 2020.

Probation - Programs in this category have completed a self-study and on-site evaluation, an interim report or an annual report and have been found in non-compliance with JRCNMT accreditation standards. The term for probation is limited to a maximum of two years.

Augusta University (GA)

Program placed on probation for one year. A progress report on standard D3.2 is due February 3, 2020.

Prince George's Community College (MD)

Probation extended for one year. A progress report on standard D3.2 is due February 3, 2020.

Caldwell Community College and Technical Institute (NC)

Probation extended for one year. A progress report on standard D3.2 is due February 3, 2020.

Thomas Jefferson University (PA)

Probation assigned for a one-year period. Progress reports on standards A3.2a and C7 are due April 1, 2020 and August 31, 2020. A focused site visit will be conducted after receipt of the second progress report and prior to the fall 2020 JRCNMT meeting.

Probation Removed - Programs in this category have submitted an interim report demonstrating compliance has been achieved on previously cited standards that resulted in probation.

Vanderbilt University Medical Center (TN)

Probation removed. Accreditation extended six years. Accreditation is conferred through December 31, 2025. A mid-cycle report is due in 2022.

Voluntary Withdrawal of Accreditation - This action is taken at the request of an accredited program.

Rutgers, The State University of New Jersey (NJ)

Voluntary withdrawal of accreditation due to program closure, effective August 1, 2019.

Approved: revision of nuclear medicine curriculum to include didactic and clinical diagnostic CT content.

South College (TN)

Approved: addition of an additional program completion pathway.

Vanderbilt University Medical Center (TN)

Approved: major revision of curriculum.
