Joint Review Committee on Educational Programs in Nuclear Medicine Technology

Notice of Accreditation Actions

Fall 2022

Accrediting agencies recognized by the Council for Higher Education Accreditation (CHEA) are required to notify the public of accreditation decisions and the basis for such decisions. The Joint Review Committee on Educational Programs in Nuclear Medicine Technology (JRCNMT) meets this requirement by publishing a notice of accreditation actions on its website within 30 business days after each board meeting. Greater detail on accreditation actions is located in the specific program's accreditation letter, which is posted in the directory of accredited programs on the JRCNMT website. The nuclear medicine technology community, regional and specialized accrediting agencies, and state agencies responsible for postsecondary education and radiation oversight are notified when a new notice of action is published.

At its meeting on November 4 -5, 2022, the JRCNMT took the following actions regarding the nuclear medicine technology programs sponsored by the institutions listed below. Specific standards listed in this report can be reviewed in the JRCNMT Accreditation Standards for Nuclear Medicine Technologist Education.

Accreditation Continued – Programs in this category completed a self-study and on-site evaluation in 2022 and were found to be in compliance with all JRCNMT standards. The term for continued accreditation runs through December 31, 2029 (seven years). A Mid-Cycle report is due in 2026.

Bellevue College (WA)

Accreditation Continued – These programs were reviewed for continuing accreditation in 2021 but were not in compliance with all JRCNMT accreditation standards. Based on submission of a satisfactory progress report in 2022, these programs received Continued Accreditation.

VA Palo Alto (CA)

Continued accreditation 6 years. A Mid-Cycle report is due in 2025.

Virginia Commonwealth University (VA)

Probation removed and accreditation continued 6 years. A Mid-Cycle report is due in 2025.

Froedtert Hospital (WI)

Continued accreditation 6 years. A Mid-Cycle report is due in 2025.

Accreditation with Conditions – Programs in this category completed a self-study and on-site evaluation in 2022 but were found to have deficiencies in meeting the noted standard(s). A progress report documenting attainment of compliance with each standard is required within the specified period of time for accreditation to be continued.

Rowan College of South Jersey (NJ)

A progress report on standard E3.3 is due August 1, 2023.

University of Findlay (OH)

A progress report on standard E3.3 is due February 1, 2023.

Probation - Programs in this category completed a self-study and on-site evaluation, an interim report or an annual report in 2022 and were found in non-compliance with JRCNMT accreditation standards. The maximum length of probation is two years, with the potential of an additional one-year extension for good cause.

Loma Linda University (CA)

Probation extended six months. A progress report on standards C1d and C1e is due February 1, 2023. A focused site visit will be conducted after submission of the progress report.

Hillsborough Community College (FL)

Program placed on probation for one year. Progress reports on standards C1a, b, d and e; D3.1e, g and h; D3.4; and E3.3 are due February 1, 2023 and August 1, 2023. A focused site visit will also be conducted after submission of the final progress report.

Miami Dade College Medical Campus (FL)

Program placed on probation for one year. A progress report addressing standards D3.1b and D3.4 is due February 1, 2023. A satisfactory Annual Report is due no later than August 1, 2023. A focused site visit may be conducted after submission of the reports.

Georgia Southern University – Armstrong Campus (GA)

Program placed on probation for one year. A progress report addressing standards D3.1b and D3.4 is due February 1, 2023. A satisfactory Annual Report is due no later than August 1, 2023. A focused site visit may be conducted after submission of the reports.

Old Dominion University (VA)

Program placed on probation for one year. A progress report addressing standards D3.1b and D3.4 is due February 1, 2023. A satisfactory Annual Report is due no later than August 1, 2023. A focused site visit may be conducted after submission of the reports.

Voluntary Withdrawal of Accreditation - This action is taken at the request of an accredited program.

Active/Inactive Program Status - Inactive status is granted when a program has no students currently enrolled. Inactive status is limited to a two-year period. Reactivation is granted when a program submits a report indicating the program continues to be in substantial compliance with accreditation standards and plans to begin enrolling students.

Inactive status approved, effective August 27, 2022.

Approved: conversion from clock to credit hours and curriculum revisions.
