#### **Accreditation Fee - Initial Accreditation**

The application fee must be submitted with the initial application for accreditation. The self-study may be submitted at the same time or must follow within one year of application submission.

## **Accreditation Fee - Continued Accreditation**

For programs undergoing reaccreditation this fee is billed in July of the year prior to reaccreditation. The invoice is mailed to Program Directors with the self-study materials. This fee is based on the size of the program by counting clinical and academic affiliates.

## **Affiliate Application Fee**

Programs may make application for approval of new affiliates at any time. The fee is charged for each individual application regardless of type (clinical or academic). Programs must pay the application fee for any new affiliates included in a self-study.

## **Annual Fee**

All accredited programs are charged an annual fee consisting of a sponsor fee plus applicable affiliate fees. Affiliate fees are charged for each clinical and academic affiliate.

Invoices for annual fees are mailed to programs on the first business day of January each year. Second notices for unpaid bills are sent by tracked email on March 1. Programs have until April 1 to submit payment. After that date programs with unpaid balances will be placed on administrative probation. The unpaid fees plus an **administrative probation rescission fee** of \$250 must be submitted for the program to be removed from administrative probation.

## **Site Visit Fee**

Programs undergoing a site visit are pre-billed for estimated costs of travel, hotel and meals for each site evaluator. When actual expenses are determined after the visit, the program will be billed for any balance due or will receive a refund if prepayment exceeded actual costs.

## **Focused Site Visit Fee (New in 2025)**

Programs on probation that must undergo a focused site visit are pre-billed a \$1000 fee plus an estimated cost for travel, hotel and meals for each site evaluator. After the visit, the program will be billed for any balance due if travel costs exceeded the prepayment or will receive a refund if prepayment exceeded actual costs.

## **Deadline Extension Fee**

Programs must pay this fee if they request an extension on the self-study submission deadline or when a self-study submission is incomplete or unacceptable and must be returned for revision. The fee is \$300 for each 30-day extension past the published deadline.

## **Additional Fees**

Failure to report a substantive change \$500

Use of an unrecognized affiliate \$500 (plus application fee to have facility recognized)

Program accreditation and affiliate application fees are non-refundable
