

Notice of Accreditation Actions

Fall 2023 – Revised December 21, 2023

Accrediting agencies recognized by the Council for Higher Education Accreditation (CHEA) are required to notify the public of accreditation decisions and the basis for such decisions. The Joint Review Committee on Educational Programs in Nuclear Medicine Technology (JRCNMT) meets this requirement by publishing a notice of accreditation actions on its website within 30 business days after each board meeting. Greater detail on accreditation actions is located in the specific program's accreditation letter, which is posted in the [directory of accredited programs](#) on the JRCNMT website. The nuclear medicine technology community, regional and specialized accrediting agencies, and state agencies responsible for postsecondary education and radiation oversight are notified when a new notice of action is published.

At its meeting on October 13 -14, 2023, the JRCNMT took the following actions regarding the nuclear medicine technology programs sponsored by the institutions listed below. Accreditation Continued – Programs in this category completed a self-study and on-site evaluation in 2023 and were found to be in compliance with all JRCNMT standards. The term for continued accreditation is seven years. A Mid-Cycle Report is due at the mid-point of the accreditation period.

Baptist Health Sciences University (TN)

Accreditation Continued – These programs were reviewed for continuing accreditation in 2022 but were not in compliance with all JRCNMT accreditation standards. Based on submission of a satisfactory progress report in 2023, these programs received Continued Accreditation.

Hillsborough Community College (FL)

Probation removed and accreditation continued for 6 years. A Mid-Cycle Report is due in 2026.

Rowan College of South Jersey Gloucester Campus (NJ)

Accreditation continued for 5 years. A Mid-Cycle Report is due in 2025.

Accreditation with Conditions – Programs in this category completed a self-study and on-site evaluation in 2023 but were found to have deficiencies in meeting the noted standard(s). A progress report documenting attainment of compliance with each standard is required within the specified period of time for accreditation to be continued.

GateWay Community College (AZ)

A progress report on standards C1c and D2.3 is due February 1, 2024.

Delgado Community College (LA)

A progress report on standards C5b and D1 is due March 1, 2024.

Pennsylvania College of Health Sciences (PA)

A progress report on standards E1.1 and E3.3 is due August 1, 2024.

Midlands Technical College (SC)

A progress report on standards D2.1 and D3.3 is due August 1, 2024.

Houston Community College (TX)

A progress report on standards C1 and E3.3 is due August 1, 2024.

West Virginia University Hospitals (WV)

A progress report on standards D2.1 and E1.1 is due February 1, 2024.

Accreditation Extended- Programs in this category received initial accreditation 3 years ago. Submission of a Mid-Cycle Report demonstrating compliance with all standards results in a 2-year extension of accreditation.

Tarrant County College Trinity River East Campus (TX)

Accreditation was extended two years. Accreditation is conferred through December 31, 2025.

Probation - Programs in this category completed a self-study and on-site evaluation, an interim report or an annual report in 2023 and were found in non-compliance with JRCNMT accreditation standards. The maximum length of probation is two years, with the potential of an additional one-year extension for good cause.

Miami Dade College Medical Campus (FL)

Probation extended one year. Progress reports addressing standards D3.1b and D3.4 are due March 1, 2024. A satisfactory Annual Report is due no later than August 1, 2024. A focused site visit may be conducted after submission of the reports.

Georgia Southern University – Armstrong Campus (GA)

Probation extended for one year. A progress report addressing standards D3.1b, D3.4 is due March 1, 2024. A progress report addressing standards C6, D3.1j and E3.3 is due August 1, 2024. A satisfactory Annual Report is due no later than August 1, 2024. A focused site visit may be conducted after submission of the reports.

Regis College (MA)

Program placed on probation for one year. Progress reports addressing standards D3.1b and D3.4 are due March 1, 2024. A satisfactory Annual Report is due no later than August 1, 2024. A focused site visit may be conducted after submission of the reports.

Ferris State University (MI)

Program placed on probation for one year. Progress reports addressing standards D3.1b and D3.4 are due March 1, 2024. A satisfactory Annual Report is due no later than August 1, 2024. A focused site visit may be conducted after submission of the reports.

University of Findlay (OH)

Program placed on probation for one year. Progress reports addressing standards D3.1b and D3.4 are due March 1, 2024. A satisfactory Annual Report is due no later than August 1, 2024. A focused site visit may be conducted after submission of the reports.

University of the Incarnate Word (TX)

Program placed on probation for one year. Progress reports addressing standards D3.1b and D3.4 are due March 1, 2024. A satisfactory Annual Report is due no later than August 1, 2024. A focused site visit may be conducted after submission of the reports.

Old Dominion University (VA)

Probation extended for one year. A progress report addressing standards D3.1b and D3.4 is due March 1, 2024. A satisfactory Annual Report is due no later than August 1, 2024. A focused site visit may be conducted after submission of the reports.

Voluntary Withdrawal of Accreditation - This action is taken at the request of an accredited program.

Reactivation is granted when a program submits a report indicating the program continues to be in substantial compliance with accreditation standards and plans to begin enrolling students.*
